



How Is ESG Measured?

Hang Seng Indexes introduced its first sustainability or ESG index back in 2010. Hong Kong Quality Assurance Agency ("HKQAA"), an independent and professional assessment body, has been appointed by Hang Seng Indexes to evaluate the ESG performance of about 500 Hong Kong-listed companies and over 1,300 A-shares companies using HKQAA's proprietary sustainability assessment and rating framework.

HKQAA's ESG rating model is designed to rate a company's system maturity and risks with regard to sustainability performance. The assessment captures both general and industry-specific criteria covering seven core subjects.
