

## Change in Membership of Hang Seng Index Advisory Committee

(Hong Kong, 7 February 2025) – Hang Seng Indexes Company Limited (‘HSIL’) today announced the following changes in the membership of the Hang Seng Index Advisory Committee (‘Committee’). The changes have come into effect.

Mr Paul Pong and Mr Vincent Kwan have retired from the Committee after years of distinguished service.

Mr Keith Lui has been appointed as a Member of the Committee. Mr Lui is currently a non-Executive Director of the Accounting and Financial Reporting Council. Previously, he was the Executive Director of the Supervision of Markets Division of the Securities and Futures Commission (‘SFC’). During his service at the SFC, he was the Chairman of the Investor Compensation Fund Committee and the Securities Compensation Fund Committee, and a member of the SFC’s Advisory Committee, the Investment Committee, the SFC (HKEX Listing) Committee and the Statutory Risk management Committee of the Hong Kong Exchanges and Clearing Limited. Mr Lui worked for various financial institutions in the US and Hong Kong in the areas of deposit taking and lending, asset management and investing banking.

Mr Franco Ngan has been appointed as a Member of the Committee. Mr Ngan has over 27 years of experience in the fund management industry and is the Chief Executive Officer and a co-founder of Zeal Asset Management Limited (‘Zeal’). Prior to Zeal, he worked at Value Partners Group Limited, Manulife Asset Management (Hong Kong) and Altamira Investment Services Inc. (Canada). Mr Ngan was a member of the Public Shareholder Group of the SFC. He was the Chairman of the China Committee of The Alternative Investment Management Association Hong Kong Chapter. He was a member of Hong Kong’s Financial Services Development Council’s (‘FSDC’) Working Group on Green Finance in the Greater Bay Area and starting from 2021, Mr Ngan has been a member of the Human Capital Committee under the FSDC.

The Committee is an independent advisory body comprised of 13 members, including 10 members who are specialists drawn from universities and the institutional investor and investment consultant communities. The Committee meets regularly to discuss matters relating to the Hang Seng Family of Indexes.
